NOVEMBER 2021 Meeting Minutes Winchester Regional Airport Authority

The Winchester Regional Airport Authority met in regular session in the conference room of the terminal building at 5:00 P.M. on November 18, 2021.

OPEN MEETING

Chairman Pifer called the meeting to order at 5:00 P.M.

APPROVE MEETING AGENDA

Motion: Approve agenda as distributed – by Frank Haun, second by John Eberhardt. Motion passed unanimously.

APPROVE MINUTES - October 14, 2021 Regular Business Meeting

Motion: Approve as distributed – by Frank Haun, second by John Eberhardt. Motion passed unanimously.

PUBLIC COMMENT

None

CHAIRMAN - OPENING REMARKS

Chairman Pifer welcomed John Eberhardt as the newest appointee to the WRAA board of directors by the City of Winchester.

COMMITTEE REPORTS

(a) Finance Report – Leslie Melanson, Secretary/Treasurer – Leslie provided a report on the pre-audit October 2021 financial statements.

Motion: Accept finance report – by Gene Fisher, second by Frank Haun. Motion passed unanimously.

- (b) Building/Lease Committee Vacant No report.
- **(c) Minimum Standards/Personnel Committee Dave Reichert, Chair –** No report. Nick commented that we have recently hired a new Flightline Technician. Furthermore, the proposed FY23 budget includes funding for the Flightline Services Supervisor position, originally conceived with the 2019 Staffing Plan.
- (d) Marketing Committee Bill Pifer, Chair Bill deferred to the Executive Director's comments for the latest update on marketing efforts.

OPERATIONS REVIEW

Dave recapped the status of the USDA contract. Wildlife sightings have been down dramatically since the program's implementation. Mowing season is drawing to a close and airport staff are actively preparing for winter operations. All key equipment is being inspected and tested for operational readiness. An order for deicer chemicals is anticipated in the next 30 days. Preventative maintenance was performed on the airport beacon, including a new ballast and bulb. A new floor sweeper was acquired through GSA Access. Two airport trucks are out for public auction. These trucks have been deemed to have exhausted their useful life due to the elevated operating costs and diminished utility. The auction is live through the end of November.

NEW BUSINESS - EXECUTIVE DIRECTOR

Recently, the airport received approval by the Fredrick County Finance Committee to support the local match of a proposed future grant for the Site Work Phase 2 project. The project will be ready for bid in December in order to submit the total project costs to the Virginia Aviation Board (VAB) meeting for consideration in February.

Motion: Authorize Executive Director to apply for, and execute, a grant to the Virginia Department of Aviation (DOAV) at the Virginia Aviation Board (VAB) meeting in February 2022 for the Terminal Site Work Phase 2 construction project. Motion passed unanimously.

Nick discussed the state of the terminal building design project. The proposed change order #1 is under review by the DOAV. A meeting with all key stakeholders is scheduled for November 19th.

The proposed FY23 operating budget was reviewed. The total budget is approximately \$2.4M, which represents a 20% increase over the current budget due to higher projected fuel costs and sales, salaries, insurance, and utilities costs. Despite the higher budget, the total operating subsidy requested from Frederick County and the City of Winchester has decreased by approximately 20%.

Nick discussed negotiations with a local rental car provider to enhance the level of service at the airport. A draft agreement is under review with no target date for implementation.

The Chamber of Commerce will host a legislative policymaker breakfast on December 9th. Nick solicited interest from the board to see if anyone was interest in attending, and if so, staff could get them registered.

Bill requested to table the WRAA Bylaws agenda item until we could get more input about the committee structure and roles and responsibilities.

Carley Walker provided an update on the nonprofit foundation ad hoc committee. We've received copies of peer airports who have established a similar foundation. We are hoping to be in position to submit the formative documents by the end of December.

COMMENTS - BOARD MEMBERS

1. **John Eberhardt** – John asked about the state of the terminal design and whether it was too late to offer design input. He suggested leveraging his contacts with NASA and other key partners who are participating in the development of the future regional air mobility to ensure we equip the terminal to meet future demand.
