FEBRUARY 2022 Meeting Minutes Winchester Regional Airport Authority

The Winchester Regional Airport Authority Board of Directors met in regular session in the conference room of the terminal building at 5:00 P.M. on February 10, 2022.

OPEN MEETING

Chairman Pifer called the meeting to order at 5:00 P.M.

APPROVE MEETING AGENDA

Motion: Approve agenda as distributed – by John Eberhardt, second by Gene Fisher. Motion passed unanimously.

APPROVE MINUTES - January 13, 2022 Regular Business Meeting

Motion: Approve as distributed – by Frank Haun, second by John Eberhardt. Motion passed unanimously.

PUBLIC COMMENT

None

CHAIRMAN - OPENING REMARKS

Chairman Pifer welcomed Rhett Champagne as the newest Authority board member appointee from Frederick County. Bill also shared positive comments made by Delta Airport Consultants and TMG at the KOKV Hangars preconstruction meeting earlier that day.

OPERATIONS REVIEW

Dave recapped the latest operations update. Recently, staffing has continued to be a challenge due to COVID or long-term FMLA related absences. A snow event in late January caused several days of cleanup and one application of solid de-ice chemical. We saw approximately 6" of snow and 1" of ice. We are in the process of beginning to prepare mowing equipment for spring operations. The gearbox on the batwing mower is in the midst of repair. Hangar 509 saw significant action during the preceding month, with several overnight stays by turbine and piston aircraft alike. The annual based aircraft survey was completed and submitted to the Virginia Department of Aviation (DOAV) and Frederick County Treasurer's Office. We are in receipt of a 2005 GMC Canyon pickup truck that was put out for interagency transfer by Frederick County Finance. We will work to get the vehicle registered and develop a plan for its use. Maintenance staff installed a new block heater for the ground power unit (GPU). Two fuel hoses on the jet trucks have been replaced. Cameras have been installed on top of the terminal building that show a panoramic view of the runway and apron environment. This will be especially useful to monitor and

document construction progress. Currently, the glideslope is NOTAM'd out of service. A call has been made to maintenance provider, Austin Electric. As a reminder, the system is owned and maintained by the DOAV.

NEW BUSINESS - EXECUTIVE DIRECTOR

Nick started by offering public thanks to the Frederick County Sheriff's Office for their support during the recent snow system. We suffered a hydraulic line failure on the blue tractor and they were quick to offer a substitute backhoe for our use.

A budget presentation was made to Warren County on January 28th and we are scheduled to deliver another to Clarke County on February 24th. For FY23 we are requesting a \$5K contribution to the capital budget from Clarke, Shenandoah, and Warren County.

We received word that the Lord Fairfax Community College Board of Directors voted to approve a new drone certificate program. The Authority provided a letter of support for this effort.

The 2nd annual VALOR 5K runway run has been proposed for April 23, 2022 between 8:00-10:00 A.M. The date was chosen to de-conflict with upcoming construction projects set to begin this spring. We are still awaiting FAA concurrence to close the runway and associated taxiways during this time; however we do not anticipate any issues. The aerodrome would remain open to facilitate air ambulance operations as necessary.

Motion: Approve closure of the runway and taxiways to host the 2nd annual VALOR 5K runway run on April 23, 2022 from 8:00-10:00 A.M. – by Bill Pifer, second by Frank Haun. Motion passed unanimously.

Nick discussed efforts to secure a budget amendment at the General Assembly to support construction of a new terminal facility. We are fortunate to have gained support for the vision of the terminal by Delegate Gooditis and Senator Vogel. Each submitted a general fund budget amendment in their respective legislative body. Nick also gave a brief recap of the Virginia Airport Operators Council (VAOC) Legislative Day in Richmond.

Nick asked Carley Walker to give an update of outreach efforts to Starbase. Carley explained what Starbase is and how Winchester is home to the only Starbase location in the Commonwealth. Recently, Carley connected with their director, Susan Corrigan, and invited Nick to participate in a presentation to a group of students. We hope it is the start of a positive new relationship with this incredible community resource.

Two other updates regarding terminal funding: A pre-application is working its way through the USDA Rural Development Program. An application will be made to the Airport Terminal Program under the Bipartisan Infrastructure Legislation (BIL).

Nick gave an overview of ongoing and upcoming capital projects. There were recent bid openings for two projects: Terminal Site Prep Phase 2 and Runway 14 Obstruction Removal Phase 1. A preconstruction conference for the KOKV Hangars project was held on February 10. A groundbreaking ceremony is scheduled for February 18th at 2:00 P.M. The Change Order #1 for the Terminal Design project was approved by the Virginia Aviation Board.

A proposal was discussed to amend the Authority committees to the following: Executive, Finance and Budget, Foundation and Community Outreach, Marketing and Business Development. Bill requested everyone review the structure and come prepared to discuss further at the March meeting.

A triennial security audit was performed by the Frederick County Sheriff's Office. A draft report was received and will be reviewed prior to submission to the DOAV.

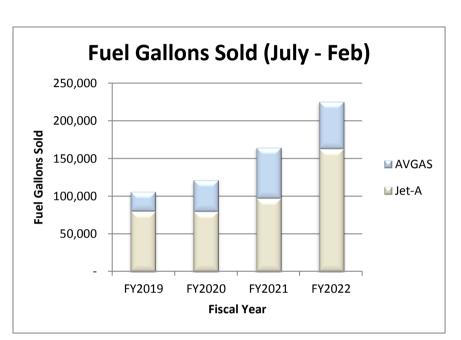
